Digital photos must be taken and submitted in their highest-resolution format (minimum 1MB).

## Judging criteria:

The judging panel will choose the shortlist from eligible photographs according to which (in his or her own opinion, which shall be final and not subject to any appeal) best satisfy the following criteria:

- Originality and creativity of the entry
- Cultural Characteristics unique to the RM of Fisher
- Overall composition
- Photographs that are submitted but do not meet the technical or content requirements shall be ineligible and shall be excluded from this
  competition.

Usage of and rights in submitted photographs

Some submitted photographs may be used in advertising campaigns by the RM of Fisher. By entering this competition, all entrants must therefore grant the RM of Fisher the right to use their submitted photographs for this purpose without payment, credit, attribution or further permission. Therefore all entrants grant the RM of Fisher a world-wide royalty-free, perpetual irrevocable and fully sub-licensable license to use, reproduce, modify, adapt, edit, publish, translate, create, derivative works from, distribute, display and otherwise utilize their submitted photograph for marketing and editorial purposes worldwide, which may include the following channels:

- Internal communications
- Print and publishing
- National, regional and trade press
- Billboard, poster mobile vehicle and other outdoor and public large-scale posters of displays, and illuminated and projected displays and irrevocably waive all image rights, performers' rights and similar rights worldwide.

Entrants agree that their submitted photograph may be combined with text and any other media, and may be altered, cropped or modified. Entrants waive the right to inspect or approve any use of their submitted photograph. Entrants acknowledge and agree that they have no right to consideration for such usage of their submitted photograph and hereby release and discharge the RM of Fisher from any liability by virtue of any uses, including any claims for libel and invasion of privacy, to the extent permitted by law. Entrants release the RM of Fisher from any liability and undertake not to prosecute or to institute proceedings, claims or demands for demands for any remuneration, or otherwise, against the RM of Fisher in respect to any usage of their submitted photograph.

Entrants who submit photographs in which they do not own the copyright, or in respect of which they are unable to grant a valid license on the terms above, agree to pay for all costs, damages, awards, fines, penalties and losses that first direct suffers as a result of using that photographs.
